SCHOLARSHIP OVERVIEW

The CAI-CLAC Memorial Scholarship has been established in remembrance of California Legislative Action Committee members to honor their service and commitment to the organization’s mission.

CAI-CLAC is providing a financial support opportunity for one (1) Homeowner Leader and one (1) Community Manager to attend the 2024 CAI-CLAC Advocacy Week scheduled for April 2-4, 2024 in Sacramento. The scholarship recipients will receive paid registration for Tuesday’s Opening Session, Wednesday’s Legislative Sessions and Thursday’s Closing Session, up to \$750 for travel and lodging expenses (if required), to be refunded to the scholarship recipient within 30-days of submission (to CAI-CLAC) of all receipts related to the event. Requirements

- Applicant must be a CAI member in good standing.
- Applicant must be currently serving as a Homeowner Leader in his/her community association or working as a Community Manager.
- The scholarship must be used for 2024 Advocacy Week held at the Sheraton Grand Sacramento Hotel.

- Funds may be used only for documented travel, lodging and meals directly related to the 2024 Advocacy Week, and the scholarship winner must stay at the conference hotel.
- In both cases, the scholarship recipient must attend the full event.
- The scholarship recipient must provide a written summary/ report of his/ her experiences at 2024 Advocacy Week within two weeks of the experience, to be used for a future CAI-CLAC blog.
- Only one (1) scholarship per individual (lifetime) will be awarded.
- Preference will be given to first-time attendees of the CAI-CLAC 2024 Advocacy Week.
